NOTICE OF PUBLIC HEARING TO BE HELD BY THE MASSACHUSETTS DEVELOPMENT FINANCE AGENCY CONCERNING THE REFINANCING OF A PROJECT FOR STURGIS CHARTER PUBLIC SCHOOL AND THE WILLIAM STURGIS FRIENDS OF EDUCATION FOUNDATION, INC. IN HYANNIS, MASSACHUSETTS. Notice is hereby given that the Massachusetts Development Finance Agency (the “Agency”) will hold a public hearing on August 7, 2026, at 2:00 p.m. Persons wishing to participate in the hearing may attend by teleconference by using the toll free telephone number and passcode listed below:

The purpose of the hearing will be to consider the issuance of qualified 501(c)(3) bonds, as defined in Section 145 of the Internal Revenue Code of 1986, as amended (the “Code”), by the Agency in an aggregate amount not exceeding \$5,000,000 for a project owned and operated by Sturgis Charter Public School and The William Sturgis Friends of Education Foundation, Inc. (together, and including for the purposes of this Notice, any parent, subsidiary or other affiliate thereof, the “Borrower”). The proceeds of the bonds will be used to (a) refinance certain outstanding revenue bond issued on behalf of the Borrower to finance and refinance the acquisition of approximately 5.97 acres of land at 105 West Main Street, Hyannis, Massachusetts, and the engineering, design, construction, installation and equipping of a two-story academic facility of approximately 46,000 square feet located thereon, (b) refinance certain other outstanding indebtedness of the Borrower used to finance and refinance the acquisition, renovation, improvement and equipping of the Borrower’s academic facility located at 441 Main Street, Hyannis, Massachusetts (comprising an approximate 11,900 square foot, one-story building, located on a 0.38 acre site), and (c) pay costs of issuance.

The bonds will not constitute a debt or pledge of the faith and credit of The Commonwealth of Massachusetts or the Massachusetts Development Finance Agency. Interested persons wishing to express their views on the project and the proposed issuance of revenue bonds to finance and refinance costs of the project will be given the opportunity to do so at the public hearing.
