NOTICE OF PUBLIC HEARING

NOTICE OF PUBLIC HEARING TO BE HELD BY MASSACHUSETTS DEVELOPMENT FINANCE AGENCY CONCERNING A PROJECT LOCATED AT 1 AND 3-20 WALKLING COURT, MEDFORD, MASSACHUSETTS. Notice is hereby given that Massachusetts Development Finance Agency (the “Issuer”) will hold a public hearing on May 8, 2026 at 9:00 A.M. via the following telephonic conference line in lieu of physical presence at the public hearing:

The purpose of the hearing will be to consider the issuance by the Issuer of exempt facility bonds (the “Bonds”) for a qualified residential rental project under the provisions of Section 142(d) of the Internal Revenue Code of 1986, as amended, to be owned by MHA Walkling Court Senior LLC (the “Borrower” which term includes in this notice any related party thereto). The Bonds will be issued in an amount not to exceed \$35,900,000 and the proceeds thereof will be used by the Borrower to finance and refinance: (i) the acquisition of a fee or ground leasehold interest in certain land and an existing residential rental housing facility thereon located at 1 and 3-20 Walkling Court, Medford, Massachusetts, known as Walkling Court, currently consisting of approximately one hundred forty-four (144) residential rental housing units and functionally related and subordinate facilities; (ii) the demolition of said buildings and the construction of a new building consisting of two interconnected towers to comprise approximately one hundred ninety-eight (198) residential rental housing units and functionally related and subordinate facilities; and (iii) the acquisition of furniture, fixtures and equipment for said residential rental housing units and functionally related and subordinate facilities (collectively, the “Project”). The Bonds will not constitute a general obligation of the Issuer or a debt or pledge of the faith and credit of the Commonwealth.
