The purpose of the hearing will be to consider the proposal of Wheaton College (together with its affiliates, the "Borrower") that the Issuer issue qualified 501(c)(3) bonds (as defined in Section 145 of the Internal Revenue Code), in an aggregate amount not to exceed \$15,000,000, to finance certain higher educational facilities owned and operated by the Borrower for educational purposes and located or to be located at the Borrower's main campus in Norton, Massachusetts, roughly bounded by East Main Street (Rt. 123), Pine Street, Fillmore Drive, Howard Street and Taunton Avenue (the "Campus"), or adjacent or proximate sites. The new projects expected to be financed include, but are not limited to, (i) renovations, accessibility improvements, renewal and repurposing, and/or deferred maintenance improvements to various buildings located on the Campus, including Mary Lyon Hall, Wallace Library, Balfour Natatorium, Balfour-Hood Café, Emerson Dining Hall and events space, Chase Dining Hall, Diana Davis Spencer Café and events space, and numerous residence halls and theme houses; (ii) water runoff and drainage infrastructure improvements, including renovation of associated landscaping and hardscapes; (iii) the acquisition of certain machinery, furniture and equipment; (iv) renewal of two boilers and systems in the central stream plant; (v) replacement of the Nordin turf field; (vi) development of a trading room; and (vii) other miscellaneous capital projects included in the Borrower's capital budget for fiscal years 2025 through 2028.

The bonds proposed to be issued by the Issuer will not constitute a general obligation of the Issuer or a debt or pledge of the faith and credit of The Commonwealth of Massachusetts.
