The purpose of the hearing will be the proposed issuance of qualified 501(c)(3) bonds, as defined in Section 145 of the Internal Revenue Code of 1986, as amended, in an aggregate principal amount not to exceed \$1,460,000,000 (the "Bonds") for a plan of financing for Mass General Brigham Incorporated (together with any affiliate thereof, the "Institution"), to finance and refinance new and existing integrated healthcare facilities owned and/or operated by the Institution and related working capital expenditures, including costs of issuing the Bonds, all such facilities located or to be located at the addresses in Massachusetts noted herein, including but not limited to:
